Discussion: Updates:

- Applied for the OASAS Grant (COVID losses)
 - Funding for two SUVs
 - Therapeutic tools for the clinic
 - Regional Office has move request up the ladder
- Opioid Lawsuit Monies
 - Lori met with Marte Sauerbrey on 11/7/22
 - Increase in Jail contract
 - Jail will be going after the state monies
- Touching base with Ann Domingo regarding the Methadone portion of the Jail Program

 - Current Methadone pick up process explained to group

 - Possibly change group times
- Efforts continue to increase census
 - Liberty Representative (works for DSS) referring to clinic as well

 - 5 Opioid for October – 13 less than last year
- OD Maps
 - Data is in and kinks are worked out
 - New report gives detail on all overdoses
 - No Deaths for October
 - Year to date Totals
 - 4 deaths in 2021
 - 2 deaths in 2022
- MAT Program

- Program is up and running
 - Meds started Monday 11/7/22
 - 7 clients - 5 on meds
 - 2 are Federal and federal will not pay for meds
 - Brand new CASAC has started
 - Cathy Healy to reach out to CACAC
 - Telehealth is available to jail
- Accreditation completed
 - Received a ding for no clinical social worker or programs
 - County can step in to help at some point
 - Seeing what the current contracted agency will do first

- TAM (Threat Assessment Management)
 - Policy to State by 12/31/22
 - Consulting with ex-FBI agent to pull together
 - Stakeholder teams to be established after
 - \$172,000 grant for Tioga County
 - Mike Simmons is the lead to organize
 - Team will be comprised of Stakeholders
 - Lori would like to give input before it goes to the State
 - Consultant reaching out to other areas that have TAM to see what they are doing then scale it down for Tioga County.

Topic: Prevention/Coalition – Christina Olevano

Discussion: Prevention Updates:

- Contracts with Waverly & Spencer VanEtten Schools going well
- Teen Intervene referral received (re: vapes as young as 11 yrs. old)
- Kids using allowances to buy from older kids at school
- Need to get information out to parents
 - Possibly run a Parent Prevention Campaign
- Narcan training held at the Newark Valley School (15-16yr olds & staff)
- Continue teaching there 4th – 8th grade
 - Had 1 Teen Intervene referral there
- Met with the Assistant Principal for Owego Free Academy regarding Teen Intervene
 - Two referrals received for vaping
 - Confiscated vapes being treated like personal property
 - Parents can pick up
 - Vapes are against School policy and legal violation
 - Law is 21 years old
 - Parent Education was being done before COVID
 - Difficult to get parents to participate in any type of presentation
 - Looking into looping Prevention into already planned event nights
 - Sports, winter concerts etc.
 - Suggested doing during intermissions
- Youth Club House had a soft launch
 - Two Fridays in November
 - Tuesday, Wednesday & Fridays in December at Joshua's House
 - MOU completed for that space
 - Target audience
 - 11-17 yr. old unconnected youth
 - Teach life skills along with fun time
 - Runs 2pm-6pm
 - No participants last Friday
- Youth Lead Out Loud Event
 - November 30th, 2022
 - National Speaker
 - Up to eight kids per school district
 - 6th – 8th grade kids
 - Hoping to launch off with Youth Coalition
- Interview with Deputy Brenda Yeager
 - Topic: Impaired Driving
 - Article will be in the Pennysaver and on Coalition website
- Looking for more ideas for commercials & PSAs
 - Looking for volunteers to be in
- Scheduling curriculum for Candor Schools
 - Starting with 10th grade students
