  - Working a lot in the Newark Valley, Waverly & Candor Schools
  - Receiving referrals thru DSS for this program
  - Receiving referrals for PPP parent program
- Working on a program with BOCES on contracting a Prevention Specialist for school districts
- OD Maps
  - Christina feels there is a discrepancy
  - Only two OD's reported since January
  - Christina to check with Shawn as he was to contact OPD to ensure they record all overdose into the OD Map system
